

**2026 Pebble Beach Concours d'Elegance® Charity Drawing (“Drawing”)
Official Rules (“Official Rules”)**

1. The Drawing period begins on or about June 22, 2026, through August 16, 2026 (“Drawing Period”).
2. Co-Sponsors: Boys & Girls Clubs of Monterey County, 1332 La Salle, Seaside, CA 93955 and Natividad Medical Foundation, 1441 Constitution Blvd., Bldg. 200, 2nd Fl., Salinas, CA 93906 (“Co-Sponsors”). By entering the Drawing, each participant agrees to comply with these Official Rules which can be found at <https://www.bgcmc.org> and at <https://www.natividadfoundation.org>. All federal, state, and local laws apply. Void where prohibited or restricted by law.
3. Eligibility Requirements: Must be at least 18 years of age, be a legal resident of one of the contiguous United States or D.C. and be able to provide proof of age and identity upon request (each, an “Entrant”). Employees of either of the Co-Sponsors or Lexus, a division of Toyota Motor Sales, U.S.A., Inc. (“Lexus”), their parents, any of their subsidiaries, affiliates, dealers, distributors, advertising agencies, or any family member of any such person or an individual domiciled with such person are ineligible to participate in Drawing.
4. To enter the Drawing, Entrants must purchase at least one (1) Drawing ticket during the Drawing Period, available through the Boys & Girls Clubs of Monterey County during business hours at 1332 LaSalle Ave., Seaside, CA 93955/ by phone at (831)394-5171 or through Natividad Medical Foundation during business hours at 1441 Constitution Ave., Salinas, CA 93906/by phone at (831)594-3902 OR between 5:30 a.m. Pacific Daylight Time (“PDT”) and 3:00 p.m. PDT at the 2026 Pebble Beach Concours d'Elegance being held at The Lodge at Pebble Beach.
5. Each Co-Sponsor will have a total of 2,250 Drawing tickets available for purchase at \$100 each during the Drawing Period (each, a “Ticket”), as specified in Section 4 above. Ticket payments may be made to the order of: Boys and Girls Clubs of Monterey County or Natividad Medical Foundation and may be made by cash, check, and money order, Visa, MasterCard or American Express.
6. Co-Sponsors will conduct a random drawing on or about 4:00 p.m. PDT on August 16, 2026 at the 2026 Pebble Beach Concours d'Elegance being held at The Lodge at Pebble Beach from among all eligible Tickets (“Random Drawing”) to select a winner (“Winner”). Winner shall receive the following prize package (collectively, the “Prize Package”):
 - a. a two-year lease for a 2026 Lexus GX Overtrail with an approximate retail value (“ARV”) of \$28,991.99, which ARV is as of date of drafting these Official Rules (“Vehicle Lease”). In the event the actual ARV is less than the stated ARV, no additional compensation will be provided;
 - b. a Pebble Beach Resorts Stay & Play Package, including a two-night stay at The Lodge and a twosome at the Pebble Beach Golf Links, which must be redeemed between November 2026 and March 2027 and is based on availability (ARV = \$6,000); and
 - c. two VIP tickets*, including VIP parking, to the 2027 Pebble Beach Concours d'Elegance scheduled to take place on August 15, 2027.

VIP ticket level shall be determined by Pebble Beach Concours d'Elegance and is based on availability (ARV = \$5,000). *No accommodations included.

Winner is responsible for all taxes, licensing and transfer fees due on the ARV of all elements of the Prize Package. No cash or prize substitutions and all elements of the Prize Package are nontransferable. The depiction of any elements of the Prize Package in any advertising, promotional materials or displays may not reflect the actual elements of the Prize Package that Winner is due to receive.

Lexus will determine all features of Vehicle subject to the Vehicle Lease ("Vehicle"), including, but not limited to, color of exterior and interior. Based on local availability, Lexus shall select the Lexus model to be provided for display at the 2026 Pebble Beach Concours d'Elegance being held at The Lodge at Pebble Beach on August 16, 2026. Winner understands and agrees that the Vehicle they receive may have up to 2,000 miles on the odometer at time of delivery. Winner must be a U.S. licensed driver and will be required to provide proof of a valid U.S. driver's license and proof of legally required insurance at time of delivery and otherwise meet all eligibility requirements contained in these Official Rules. For the duration of the Vehicle Lease, Winner is responsible for title, applicable taxes (including, without limitation, any incremental income taxes and any sales, use, lease or property taxes), license, registration, dealer preparation costs, legally required auto insurance and other fees associated with possession and/or use of the Vehicle. Lexus shall not have any responsibility or liability whatsoever for any property loss, damage, personal injury, or death, in connection with the Vehicle Lease being awarded pursuant to the Drawing and/or any person's participation in the Drawing; provided, however, that Lexus shall be solely responsible for any express written limited warranties specifically set forth in the applicable Owner's Guide for the Vehicle subject to the Vehicle Lease. Winner must take delivery of Vehicle Lease from the automobile dealership designated by Lexus. Lexus shall not be responsible for delays in delivery of Vehicle subject to the Vehicle Lease and delivery is subject to availability. Lexus, however, shall use all reasonable efforts, subject to availability, to deliver the Vehicle subject to the Vehicle Lease to the Lexus-designated delivery dealer within thirty (30) days of completion of Vehicle Lease agreement and verification process, as stated in this Section 6. Winner shall bear all risk of loss or damage to the Vehicle subject to the Vehicle Lease after it has been retrieved by the Winner. Winner must personally complete the actions specified in this Section 6 or the right to claim the Vehicle Lease will be lost. Should Winner be ineligible or unable to accept the Vehicle Lease for any reason, no alternate/substitute prize, including a cash equivalent, will be offered in lieu of the Vehicle Lease and Winner will forfeit same.

Prior to taking possession of the Vehicle Lease, Winner will be required to:

- (a) execute a Vehicle Lease agreement, as required by Lexus
- (b) complete any other paperwork required for Vehicle Lease, as requested by Lexus;
- (c) execute (and have notarized) a Release, if legal, within ten (10) calendar days of notification thereof;
- (d) provide to Lexus proof of a valid U.S. driver's license and legally required auto insurance, as well as full address, social security number and signature; and
- (e) make payment to Lexus or the Lexus-designated delivery dealer, for all taxes, license fees, delivery charges, and any other costs due in relation to Vehicle Lease prior to Winner's receipt of same.

If Winner does not or is unable to complete all of the above actions in order to claim the Vehicle Lease for any reason within the time frame, as specified in this Section 6, an alternate winner will be randomly drawn from remaining eligible Tickets.

7. All Tickets benefit Co-Sponsors, both of which are California 501(c)(3) organizations.

8. All Tickets must be fully completed. No mechanically reproduced, computer-generated or any other form of Ticket will be acceptable. All Tickets shall be subject to verification. Co-Sponsors will destroy all Tickets after verification of Winner, as defined below.

9. Co-Sponsors, Lexus, Pebble Beach Company and Pebble Beach Concours d'Elegance are not responsible for late, lost, misdirected, incomplete, illegible, postage due or stolen Tickets via mail, or for technical malfunctions, or failed, incorrect, inaccurate, incomplete, garbled or delayed electronic communications whether caused by the sender or by any of the equipment associated with or utilized in this Drawing or by any human error which may occur in the processing of Tickets.

10. Winner need not be present to win. If not present at the Drawing, Winner will be notified by telephone or email within five business days following the Drawing.

11. Odds of winning depend on number of eligible Tickets purchased during the Drawing Period.

12. The Co-Sponsor responsible for selling the Winner's Ticket will provide to Winner a 1099 for the ARV of Vehicle Lease. Winner is solely responsible for reporting the ARV of Vehicle Lease to all applicable tax authorities. Co-Sponsors and Lexus make no representation regarding the tax implication of winning Vehicle Lease. Winner should contact their tax advisor for further information.

13. Winner agrees to release Co-Sponsors, Lexus, Pebble Beach Company and Pebble Beach Concours d'Elegance from any injuries, losses or damages of any kind resulting from acceptance, possession or use of the Vehicle Lease and/or the Vehicle subject to the Vehicle Lease.

14. Winner grants Co-Sponsors, Lexus, Pebble Beach Company and Pebble Beach Concours d'Elegance, the right to use their name, photo and/or any element of the Vehicle Lease in any and all format for advertising and publicity purposes without additional compensation.

15. Co-Sponsors will not collect or use any Drawing participant's personal information for any purpose other than for fulfillment of the Drawing.
